I wanted to apologize again for my mess up with the election months.

I was looking at our old bylaws and got the months wrong but caught it at the last minute so we held our board and officer elections at our January general meeting instead of February. Speaking of the bylaws, It was brought to our attention that according to our current bylaws that "the nomination and election of officers and board members will be held at the January meeting" however in the hopes of making the meeting go as swiftly as possible (some complaints have been heard about the general meeting taking to long and needing to be hurried up) it had been announced at the prior 3 months (October, November and December) general meetings that the board would be accepting nominations anytime (as long as the nominee accepts it, of course) as well as during the election meeting.

Even though not all of the members of our board/officers are "overwhelmed with excitement" to be in the positions they have taken you need to remember they all "stepped up" and are willing to donate their personal time and energy for the betterment of our club and I want to highly commend them for that!

In March I will be stepping down as your president and this will be one of the last POV's you will receive from me so I will leave you with a quick little reminder that as a brotherhood if you would like to see this club exist for our future generations we need to work together with understanding and patience
